9. **RULES FOR PARTICIPATION**
 - The right to take part in the competition is given to competitors and athletes aged 25 (year 1993) and older;
 - Competitors must submit a written statement that they are healthy and start on their own responsibility. The completed and signed original statement should be forwarded to the organizers;

- The final result of the OPEN according to the Super Cup Cup score is calculated as the product of the sum of all 5 starts (in seconds) and the age coefficient (point 18 of the Regulations),
- Competitors starting in less than 5 events will not be taken into account in the OPEN Super Cup Masters score.

10. REGISTRATRIION FORM:

- Competitors representing clubs must report to the competition only as part of the club entry. Non-affiliated competitors report individually;
- Club entries to the competition should be sent in electronic form, lxf file generated in SPLASH ENTRY EDITOR (* .lxf). Invitation to download at www.megatiming.pl. The application must contain: name and surname of the competitor, full date of birth (DD / MM / YYYY), club name, distance, competition and the best time obtained in the last 12 months. The application must contain contact details (phone and email) of the person preparing the application.

11. TERM OF APPLICATIONS:

Applications should be sent in electronic form to the address elachodyna@poczta.fm by the deadline of 07.05.2018. Each application will be confirmed by e-mail within two days, if you do not receive such confirmation, please for telephone contact with Ms. Elżbieta Chodyna +48 600215732.
